Product Description

J&M's ROKKER XXR series 6.71" speakers designed as exact size component/replacements for the stock 6.5" Harley rear trunk-pod or lower-fairing speakers as installed on the 2014-2020 Harley Ultra or Ultra Ltd. (NOT applicable for liquid-cooled lower-fairings)

Spec'd at 2 ohms impedance and 300 watts maximum input (175w RMS - 91db sensitivity), speakers provide the ultimate in raw audio power and include the new custom grills with built-in high-output tweeters.

Lightweight waterproof one-piece woven-fiber driver cone with super-rigid metal basket design.

High-density lite-weight Neodymium magnet structure, specially coated to maintain flux-strength integrity even at extreme operating temperatures.

High efficiency VENTED voice-coil for improved cooling when operating at high volume levels for extended periods.

Custom speaker grills with high-output tweeters for crystal clear sound at highway speeds.

Mounting hole pattern and spade electrical connections are exactly the same as the factory specification, this is a total plug-and-play no-modification solution complete with easy to follow installation instructions.

These are THE most powerful speakers you can buy for your Harley and they will perform extremely well when used with a medium to high-powered accessory amplifier.

Installation Instructions

1. Remove both of the stock Harley rear trunk-pod or lower-fairing speakers. (**Figure A and B**)
2. Identify the ROKKER XXR speaker/grill assembly for the left side, plug-in the wire spades and install complete assembly oriented as per the diagram below.
3. Identify the ROKKER XXR speaker/grill assembly for the right side, plug-in the wire spades and install complete assembly oriented as per the diagram below.

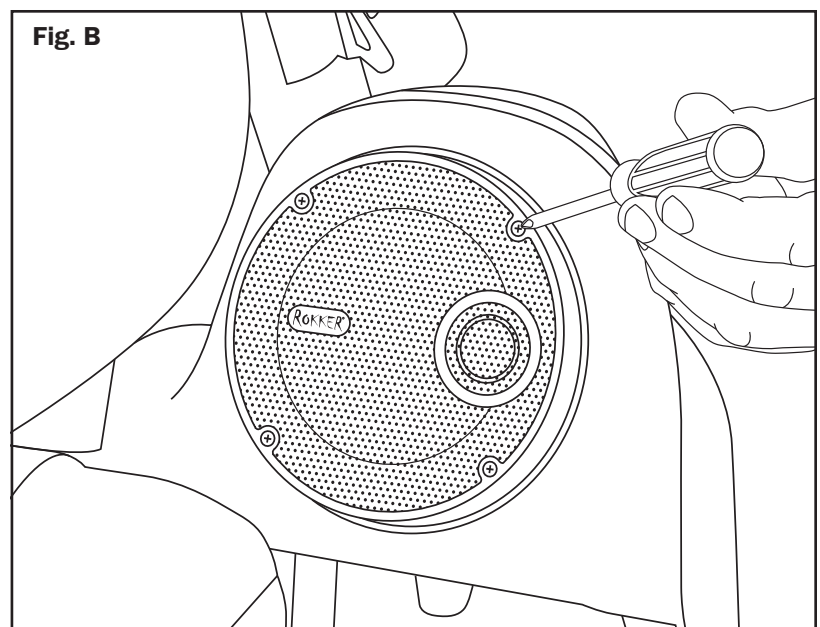
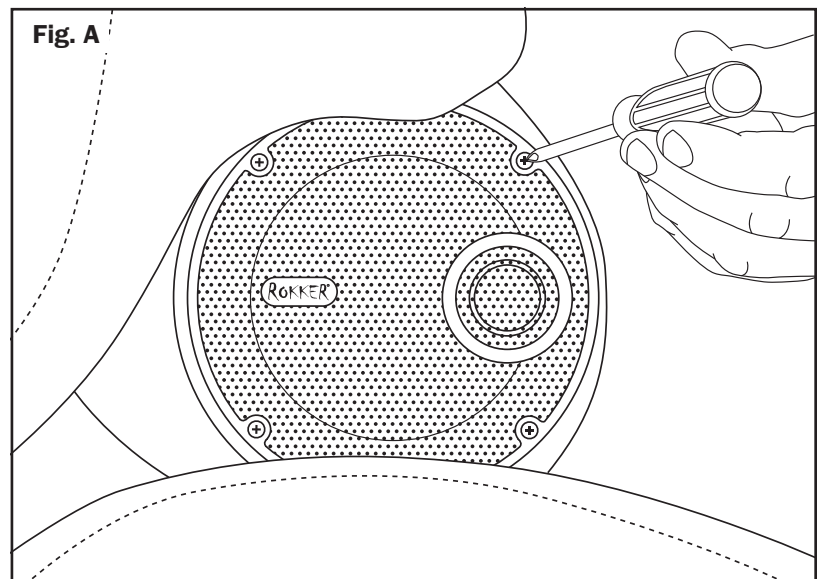
Important Note #1: For both the left and right side rear trunk-pod or lower-fairing speakers, you want to install them so that the grill-mounted tweeter is oriented to outer position.

Important Note #2: Do not over tighten the attachment screws as the Harley rubber well nut inserts will pull completely out of the rear trunk-pod or lower-fairing housing assembly.
